# An Audit of Audits

#### HOW HAVE THE OBSTETRICS & GYNAECOLOGY AUDITS AT FIONA STANLEY HOSPITAL, A WESTERN AUSTRALIAN TERTIARY CENTRE, PERFORMED OVER 3 YEARS.

As part of the Safety, Quality and Risk (SQR) team, we facilitate departmental Quality Improvement (QI) activities, including audits. We promote satisfactory progression through the audit cycle to close the audit loop, thereby optimising invested resources, patient safety, clinician engagement and educational opportunities for rotational junior doctors.

**AIMS:** To investigate if our audits systematically complete the stages of an audit cycle. Additionally, we identify what proportion of our audits are consultant-led, the duration of audits and which aspect of patient care is being addressed.

**METHODS:** Data was collected from the hospital-wide QI database over 3 years. We included O&G medical audits. Non-O&G led audits and research projects mislabelled as audits were excluded.

#### **RESULTS**

46 out of 57 (80.7%) projects were included.

- ✓ Consultants were involved in 93.5%.
- $\checkmark$  87% were completed within 1 year.
- ✓ 97% of projects of over 6-month duration were completed.



#### Audit outcomes

58.8% of audits met their standards. 5 projects provided baseline data to larger ongoing departmental QI initiatives. Excluding these, standards were unmet in 9 cases (26.5%)

- ✓ Recommendations were made in all and implemented in 8 audits (88.9%).
- Re-audit or planned re-audit rate was 44.4%.
- ✓ Audit loops were closed in 71.7% by primarily meeting standards or on re-audit.

What was being investigated?



- 32.7% were Obstetrics and 14.3% were Gynaecology audits.
- 3 were Covid-19 related audits. 2 were reaudits of prior projects. 2 were recurring departmental audits.

### DISCUSSION

We performed well in providing consultant supervision, completing most projects and doing so within an adequate timeframe. Equally satisfactory was the closing of audit loops and implementation of recommendations.

Identification of relevant standards and reaudit however was suboptimal. Recommendations of this audit have provided insight into the role of our SQR team and defined practical ways to enhance the quality and impact of our QI projects.
